Dear NAE4-HA Retiree,

The Northeast Associations of Extension 4-H Agents are hosting the 2009 National Association of Extension 4-H Agents (NAE4-HA) Professional Conference and Annual Meeting in Rochester, New York. We will host over 1,000 4-H Youth Professionals from across the nation and welcome them to the Northeast in October of 2009. Plans are well underway and our members from Connecticut, Delaware, Maine, Maryland, Massachusetts, New Hampshire, New Jersey, New York, Pennsylvania, Rhode Island, Vermont, West Virginia, and Washington, D.C. are hard at work preparing for this event.

We are serving as the Fund Raising Co-Chairs for the Conference and we have begun to establish a sound financial footing for the meeting. Significant internal contributions of over \$60,000 have been provided by the northeast states. The Northeast states have contributed \$20,000 and National 4-H Council has presented us \$40,000 in support of this conference. We are looking for additional donations to enhance our endeavors.
